**<u>CORPORATION DESCRIPTION</u>:** California Human Development (CHD) is a private, non-profit, human service agency that provides a wide range of programs and services throughout Northern California.

These programs are designed to prepare low income adults and youth including migrant and seasonal Farmworkers and other disadvantaged, unemployed and underemployed individuals for full participation in the labor force. Services include all WIOA Career Services (Basic, Individualized & Training), Counseling, education, job training, Work Experience, Vocational Training, On-the-Job Training, Emergency Support Services and English Language classes.

The results from completing the training include increased self-sufficiency, higher occupation skills and increased education which lead to satisfying careers, job security and prosperous lives.

**SUMMARY:** This is an instructional work teaching position under a comprehensive training program for economically disadvantaged and/or unemployed persons. - B. Instruct and tutor students; use materials, videos, audio tapes and other devices to demonstrate methods and procedures used to accomplish a work situation. This includes; training in attitudes reliability, job readiness and interviews.
- C. Through conducting individual counseling, motivates students toward greater achievement in skill work performance and in maintaining a good attendance record, works with students to enable them to succeed in achieving employment.
- D. Evaluate and grade students in accordance with established curriculum.
- E. Operates in a spirit of team work with the staff, jointly assessing needs of each student and works together in the guidance and development of the student.
- F. Actively participate in the safety program and provide meaningful suggestions for working safely.
- G. Other duties as assigned.
