STUDENT'S RIGHT TO CANCEL

California Human Development corporation/Anthony Soto Employment Training Centers will refund 100 percent of the amount paid for tuition charges without penalty or obligation if notice of cancellation is made on or before midnight of the seventh day after the first day of instruction. Exception to the rule is the third day after enrollment for the Forklift Operation and Safety training. Notification of withdrawal or cancellation and any request for a refund should be made in writing to the Center Manager. For non-starters or students that cancel contracts prior to class start date, all refunds due will be made within ten (10) days of the class or the date of cancellation. For enrolled students, all refunds due will be calculated from the last date of attendance and are paid within forty-five (45) days from the documented drop date. The documented drop date is determined by written notice from the student or by applying the school attendance policy. **Note:** for veteran refund policy, refer to school catalog.

Prepaid tuition will be refunded on a pro-rata basis for any termination that occurs on or before 60 percent of the program clock hours of instruction.

The pro-rata amount will be computed by using the ratio of the number of hours of instruction completed to the total number of hours of instruction scheduled for a given program. STUDENT'S RIGHT TO CANCEL

California Human Development corporation/Anthony Soto Employment Training Centers will refund 100 percent of the amount paid for tuition charges without penalty or obligation if notice of cancellation is made on or before midnight of the seventh day after the first day of instruction. Exception to the rule is the third day after enrollment for the Forklift Operation and Safety training. Notification of withdrawal or cancellation and any request for a refund should be made in writing to the Center Manager. For non-starters or students that cancel contracts prior to class start date, all refunds due will be made within ten (10) days of the class or the date of cancellation. For enrolled students, all refunds due will be calculated from the last date of attendance and are paid within forty-five (45) days from the documented drop date.
