Summary Description: Under the supervision of the ASET Center Manager, the Welding Instructor is responsible for organizing, developing, and implementing a comprehensive welding training program for participating students in an actual shop area-work situation. Using their own welding experience, materials, instruments, and machinery, the Welding Instructor teaches and demonstrates welding procedures and motivates trainees toward greater achievement.

DUTIES AND RESPONSIBILITIES:

- Prepares course outlines and schedule with the help of the ASET Center Manager.
- Considering the number of students enrolled, develops lesson plans and the most workable plan for effecting good teaching techniques.
- Instruct and tutor welding trainees using online and physical materials, precision instruments, various shop machines, and other tools and devices to demonstrate methods and procedures used to accomplish a work situation.
 - Classes include training in job readiness, reliability, and interviews.
- Motivates trainees toward greater achievement in skill work performance and in maintaining a good attendance record through instruction and through individual counseling sessions.
- Operates in the spirit of teamwork, assessing the needs of students, providing tutoring, and working to guide and develop each student according to their learning needs.
- In collaboration with the student case manager complete monthly Progress Reports for each student.
- Performs light maintenance on welding equipment when necessary.
- Has the ability to use good judgment to resolve difficult situations with students.
- Actively participates in the safety program, provides meaningful suggestions for working safely, and carefully observes the working environment reporting all safety hazards and dangerous situations to prevent accidents.
- Performs other related duties as assigned.

Required Skills and Abilities

- Ability to read and interpret documents such as safety rules, operating and maintenance instructions, and procedure manuals.
- Ability to write routine reports and correspondence.
- Ability to speak effectively before groups of customers or employees of the organization.
- Ability to use mathematics as they apply to the position.
- Ability to solve practical problems and deal with a variety of concrete variables in situations where only limited standardization exists.
- Ability to use independent judgment to provide guidance and solutions in difficult situations.
- Ability to interpret a variety of instructions furnished in written, oral, diagram, or schedule form.
- Ability to operate a variety of different welding machines.

Education and/or Experience

- High School diploma or GED required.
- Three years of welding experience with SMAW, GMAW, FCAW, and GTAW certifications.
- An equivalent combination of education and experience is acceptable.
- Welder fabricator experience preferred.
- Bilingual in English/Spanish, preferred.

Certificates, Licenses, Registrations

- Must be able to travel to meetings and events. If using a personal vehicle, must provide proof of insurance and provide a copy of a valid driver's license to be insurable under the agency's insurance policy.
- Must possess a smart phone with the capability to install security authentication application to securely access the CHD network.
- Current Welding Certificates for SMAW, GMAW, FCAW, and GTAW. If not currently certified, recertification must be completed within 90 days of hire.

Physical Requirements

Regularly: Stand; Walk; Manual dexterity; Reach with hands and arms; Stoop, kneel, crouch, or crawl; Talk or hear; Lift up to 25 pounds

Occasionally: Sit; Climb or balance

Vision: Close vision (clear vision at 20 inches or less); Peripheral vision (ability to observe an area that can be seen up and down or to the left and right while eyes are fixed on a given point); Depth perception (three-dimensional vision, ability to judge distances and spatial relationships); Ability to adjust focus (ability to adjust the eye to bring an object into sharp focus);

Work Environment

Regularly: Work near moving mechanical parts; Fumes or airborne particles; Toxic or caustic chemicals; Extreme heat (non-weather); Risk of electrical shock; Work with explosives; Risk of radiation; Work with explosives; Risk of radiation

Frequently: Work in high, precarious places; Extreme cold (non-weather);

Occasionally: Wet or humid conditions (non-weather); Outdoor weather conditions;

Noise level: Very loud (examples: jackhammer work, front row at rock concert)
